WHEREAS all these above stated advertisement(s) were published on the basis of the Recruitment Rules issued vide Notification No. HF/O/MERT/1561/GA(Nursing/IN-76/2012 dated 30.12.2012 which inter-alia states:

WHEREAS in the aforesaid advertisement(s) published by West Bengal Health Recruitment Board the portion “other than Government Colleges of Nursing’, has not been specifically mentioned, due to inadvertence.

Therefore, it is hereby clarified that, Under Clause K; Instruction to the candidate, in all the aforesaid advertisements, the following point should be read as below:

Method of Recruitment: By Lateral Induction from among the nursing personnel employed under this State Government in the cadre of West Bengal Nursing Service and West Bengal General Service, in health facilities and institutions other than Government Colleges of Nursing through the West Bengal Health Recruitment Board.”

Further, it is also hereby clarified that if anyone, among the nursing personnel employed under this State Government in the cadre of West Bengal Nursing Service and West Bengal General Service, in Government Colleges of Nursing has already applied for the aforesaid post (s) as stated above , she will not be treated as eligible for the post(s), as per provisions contained in the Recruitment Rule and application fees paid by her shall be refunded by West Bengal Health Recruitment Board, in due course of time.
